- 1. Call to Order and Roll Call President Peterson called the Regular Village Board meeting to order at 7:00p.m. Present were Trustees Aarud, Barbour, Dammen, Risseeuw, Troha. - **2. Approval of Minutes:** Trustee Aarud made the motion to approve the minutes of the Regular Village Board Meeting March 18, 2025, Trustee Dammen seconded the motion. Motion carried 6-0.

- c. President Peterson moved to appoint Deb Torkilson to the Village Board to replace Trustee Laatz, Trustee Risseeuw seconded. Motion carried 5-0.
- d. Clerk/Treasurer Franseen swore in Stacy Beals and Deb Torkilson.

5. Reports:

- a. Chief Officers Rufer and Schumer and Chief participated at the elementary school for the "Read Across America" program. Officer Cisneros graduated from The Northwestern School Of Police Staff and Command and will be promoted to full time when Officer Rufer retires in May. He is still working on the annual report.
